- (2) In the description under Para 10.02 of the Bill of Quantities PART A "CIVIL WORKS, PLUMBING AND LANDSCAPING", the words "item 8.01" shall be replaced by the words "item 10.01"

02	Page 12 Clause 13.3; Whether Service tax is applicable for above contract and if yes then it is reimburse by NRDA	The clause is clear. Service Tax shall not be reimbursed.
03	Page 11 of Clause 12.10 and 19.20; Tender documents are issued by department on Payment and BOQ/Price bid is enclosed by NRDA in technical tender paper. Earlier we have submitted tender with 4 envelopes i.e A contain-EMD, B for Technical papers C for price bid and D contain all above A,B and C. Please clarify tender submission procedure for this tender.	
04	Page 17 of Clause 36.1; Daily Fee of Rs. 8000 plus reimbursable expenses is to be paid to Learned Adjudicator. Weather above Fees is applicable for all days of contract period or for working / sitting dated taken by Adjudicator for adjudication.	It is clarified that, Daily Fee of Rs. 8000 plus reimbursable expenses shall be paid to Adjudicator only for the days on which he shall perform the functions of Adjudicator and not for all days of the contract period
05	In item no. 10.02 extra over item 08.01 for truss work but in our opinion extra over should be paid for 10.01 not for 8.01.	Please refer to the S. No. 2 of the amendment
06	Set of Drawings were issued with tender document whether we have to submit issued drawings along with tender with seal and signature and in which part of envelope.	It is clarified that all the documents issued as part of bid shall be necessarily submitted along with the Bid
07	Please define "Similar work" appearing in clause 4.5 A (b)	Similar work refers to the works which are envisaged under this contract. The type of works envisaged are described in Section 4 (Contract Data) of the bidding document. Similar works are building construction works which involved RCC, masonry and steel fabrication works.
