- 1. This Request for Expressions of Interest follows the general procurement notice for this project that appeared in *Development Business*, Issue Number 737 of October 01, 2008.
- 2. The Government of India has received a grant from Global Environment Fund [GEF]/ International Bank for Reconstruction and Development and intends to apply part of the proceeds of this grant to payments under the contract for Technical Consultancy for Preparation of Service Plan for BRTS Lite Services, under SUTP Naya Raipur. The Technical Consultant is to be procured by Naya Raipur Development Authority (NRDA), Raipur, Chhattisgarh.
- 3. NRDA is a Special Area Development Authority constituted under C.G. Town & Country Planning Act, 1973; by the Government of Chhattisgarh for planning and development of a green field city "Naya Raipur" for its capital functions.
- 4. Project: Under the GEF India Sustainable Urban Transport Program (SUTP) being implemented by the Ministry of Urban Development (MoUD), Government of India, Naya Raipur Development Authority (NRDA), has availed funds to provide urban transport infrastructure and services between Raipur and Naya Raipur and within Naya Raipur. These investments are expected to promote environmentally sustainable public transport, which are efficient, reliable and user-friendly. NRDA intends to operate Bus Service between Raipur Naya Raipur and within Naya Raipur with the following objectives
 - i. To provide safe, reliable, rapid and comfortable mode of public transport system
 - ii. To optimize transit travel times,
 - iii. To ensure efficient fleet management and, performance
- 5. Three bus corridors have been selected for bus services
 - a. Corridor-I BRTS Lite services (25km) from Raipur Railway Station to Capitol Complex in Naya Raipur, Via NH-53
 - b. Corridor-III BRTS Lite services (18km) Within Naya Raipur
 - c. Corridor-II City bus services (35km), from Kabir Nagar to Capitol Complex in Naya Raipur Via NH-30

- 6. Broad Scope of Services for the Project Management Consultant (PMC) would include:
 - (1) Carryout required Traffic Surveys and develop the data base for the preparation of Bus Service plan between Raipur and Naya Raipur and within Naya Raipur with special focus on the three BRTS Corridors and demand forecasts based on population and employment forecasts.
 - (2) Preparation of a realistic bus service plan for the base year and for a horizon period for a period of 5 years from the base year for Naya Raipur.
 - (3) Delineate and plan the location for interchange stations for city buses and BRT buses between Raipur and Naya Raipur on the BRTS corridors in Naya Raipur.
 - (4) Preparation of block cost estimates and carryout Financial analysis based on the proposed service plan.
 - (5) Recommend an appropriate fare structure and fare collection mechanism
 - (6) Recommend an appropriate institutional arrangement for planning and monitoring of BRTS operations in Naya Raipur.

7. Duration of Consultancy

Duration for this consultancy is expected to be 6 months.

- 8. The Naya Raipur Development Authority now invites qualified, experienced and eligible technical consultants to indicate their interest in providing the Services with all supporting documents, substantiating qualification to perform the services, experience in similar assignments and skills among staff for carrying out study. Interested consultants must provide information indicating that they are qualified to perform the Services (brochures, description of similar assignments, experience in similar conditions, CVs showing availability of appropriate skills among staff, etc.).
- 9. Consultants may associate to enhance their qualifications. The "Association" may take the form of a joint venture (with joint or several liability) or of a sub consultancy.
- 10. A consultant will be selected in accordance with the procedures set out in the World Bank's Guidelines: Selection and Employment of Consultants by Bank Borrowers January 2011
