

Addendum/ Corrigendum

1. Eligibility:

- a. The tenders are open only to the OEM's as listed in the tender document (also available on our website) or their authorised channel partners.
- b. Each OEM may participate in the tenders only once i.e. either themselves or through one of their designated channel partner. In any event no OEM shall quote with more than one tender i.e. either through themselves or through their channel partners.
- c. In addition to the above, they must also fulfil any other criteria prescribed in the tender documents.
- d. Notwithstanding anything to the contrary contained in the Addendum/ Corrigendum, the list of approved OEM's/ Approved makes shall prevail as already stated in the tender documents.

2. Estimated Tender Value

The Estimated Tender Value shall read as Rs. 7,71,09,915/- (Rupees Seven Crores Seventy One Lakhs Nine Thousand Nine Hundred and Fifteen Only)

3. Ernest Money Deposit:

The Ernest Money Deposit (EMD) shall read as Rs. 7, 71,099/- (Rupees Seven Lakh Seventy One Thousand Ninety Nine Only)

4. Financial documents:

Audited reports, published & issued to share holders, shall be accepted, provided the submitted copies have been notarised.

5. Posting Engineer at Site:

Engineer/s shall be posted at site once the equipments are dispatched from the factory.

6. Site Conditions:

It is assumed that all tenderers have carefully examined existing site/ as-built conditions. No modifications can be made in the executed works. The OEM's shall make necessary changes in their equipments to suit existing site conditions, where required.
